Friday through Sunday only \$65 golf guest fee and includes green fee, cart fee a round of drinks and appetizers! This rate goes to \$55 after 2 PM.

~ **Our famous Party Under the Pavilion!** During the summer months, members enjoy Party Under the Pavilion once a month. This complimentary evening includes a dinner buffet, open bar and live band. Members are invited to bring guests, complimentary, as well.
